PRESIDENT'S REPORT

Langan Initiative

Refers to N. DeRose's letter to Governor Christie on 5/14 deadline. The letter was written on behalf of Langan and distributed to BOT. The Association's support was requested if meetings are scheduled with the Governor's office. The letter offered **a** solution of more enforcement discretion to those who could not meet the deadline rather than discussion of the deadline. No concerns with letter by BOT.

EXECUTIVE DIRECTOR'S REPORT

- Status of Legislative Communications
- S. Boyle reported that the Chemistry Council of New Jersey (CCNJ) is working with Assemblyman Ramos , who is a member of the Economic, not Environment Committee, on legislation to amend the 2014 deadline. Steve Chranowski of CCNJ advised that Ramos is on board with the issue, although no legislation is posted.
- S. Boyle advised members of the round table discussion "Environmental Justice" with Assemblywoman Spencer on July 17th. Concerns with permit issues under ISRA and the possible impact of Assembly Bill 3836 upon LSRPs. A property in a known hazardous discharge area is needed to qualify as a burdened community. S. Boyle will attend and will also invite B. Alter.

Advised by Tracy Straka that Commissioner Martin is having "coffee talk " meetings, similar to constituent meetings, with organizations on a quarterly basis. S. Boyle will contact Commissioner's scheduler for more information to determine whether we want to be invited.

Boyle will update BOT after speaking with B. Alter. Registration for course may be \$350 per person. Concern that we may not have enough time to advertise course. Committee wants to send out message on upcoming events.

A Sept. mixer for young professionals is being planned with Pizzeria Uno in Metuchen as the probable venue. Event will include presentations on what it means to be an LSRP and how young professionals should prepare for the profession. A cash bar will follow. BOT was encouraged to share news with their young professionals who should be on the LSRP track.

LSRP Insurance Providers – Dale Group & Falcigno Group – B. Call
