Certificates of Attendance for these courses will be verified through the QR code system and provided electronically via email within two weeks following the NJSRC.

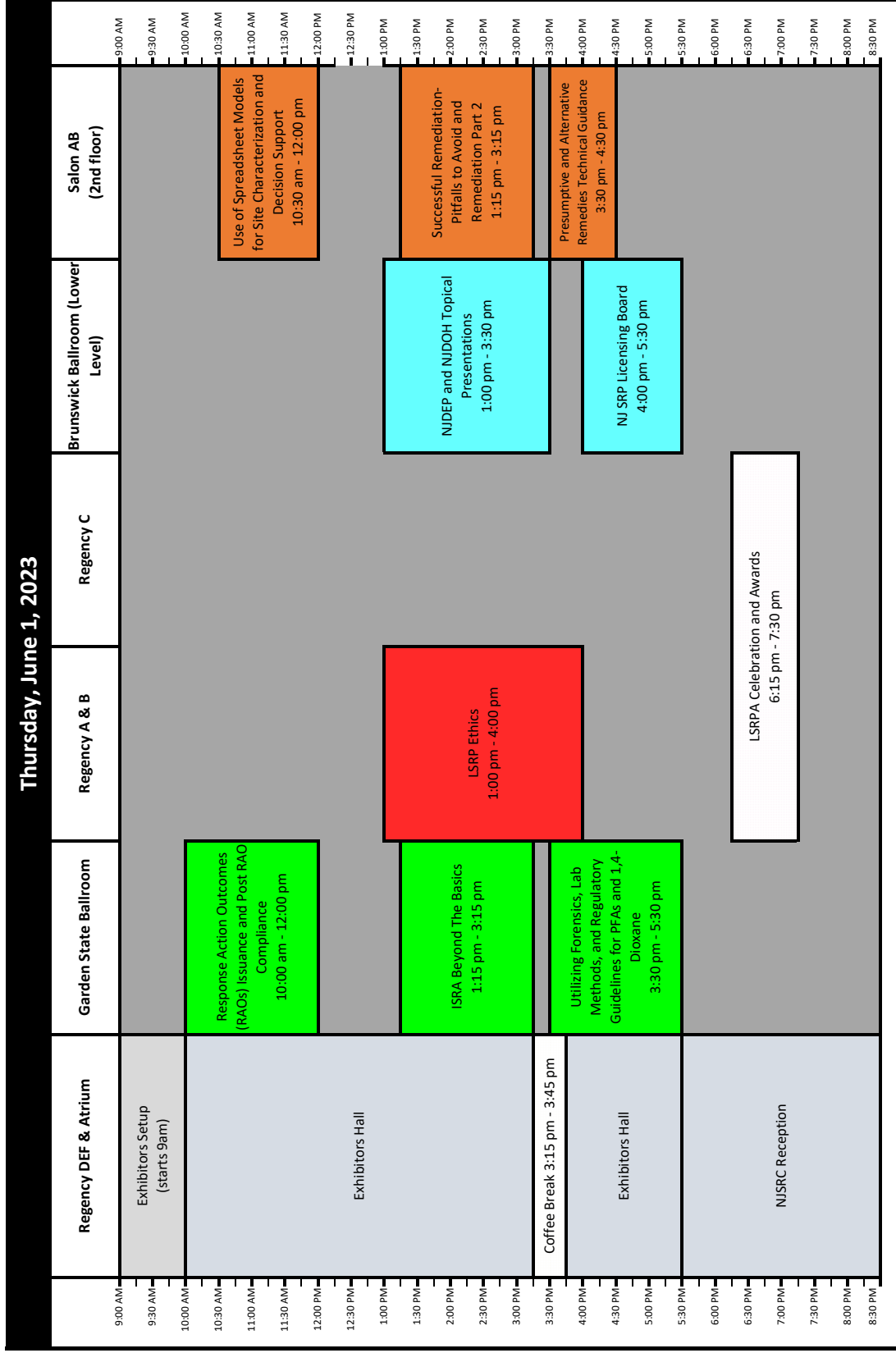

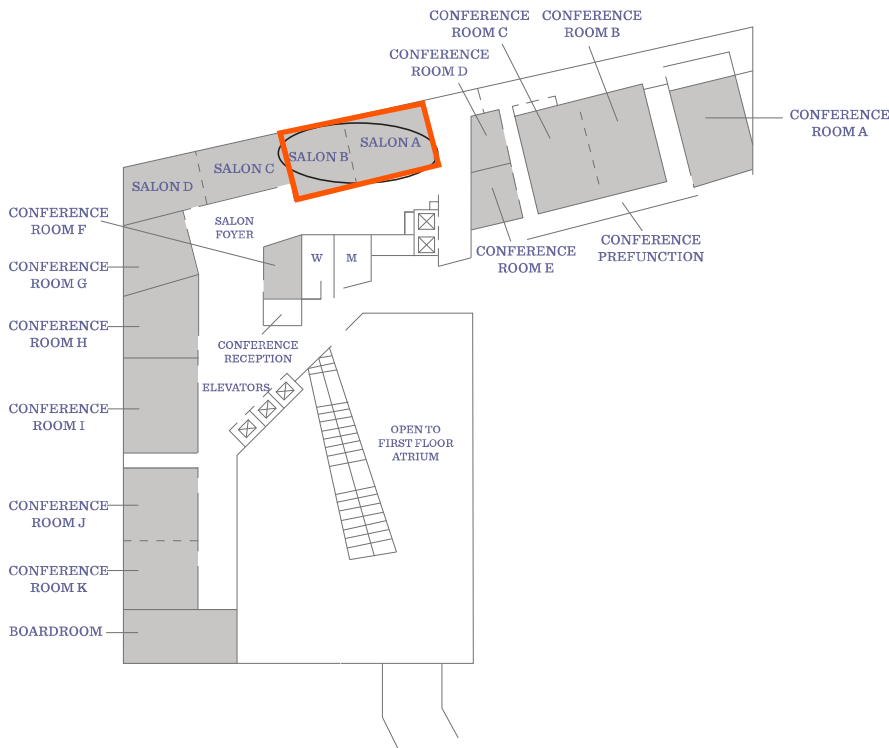


FLOOR PLAN *First Floor*

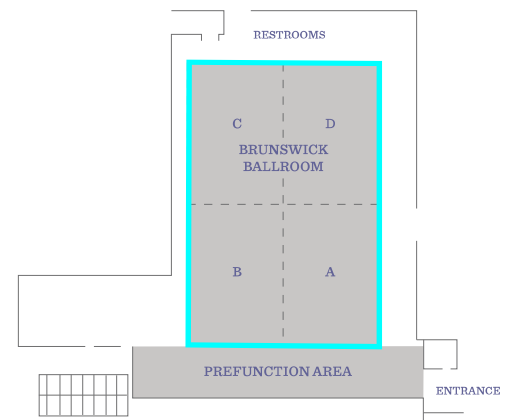
